5. **(a)** Attention of the tenderers is drawn that If any condition stipulated by Cantonment Board in the tender documents is omitted or modified or proposes alteration to any of the conditions/specifications, laid down in the tender documents or proposed by new conditions whatsoever is liable to be rejected. Any tender who does not comply with this requirement is liable to be considered as non bonafide.  
**(b)** No omission or modifications are acceptable with regard to the followings:-
  - (i)** Commencement and completion of works as provided in tender documents.
  - (ii)** Scheme in general**(c)** Attention of the tenderers is drawn that conditional tenders are liable to be rejected. In spite of this, it has come to our notice that tenderers are in the practice of attaching their own conditions. 1. A tender is invited for the work as mentioned in Notice inviting e-Tender including appendix 'A' to Notice inviting e-tender.
2. The work is estimated to cost as indicated in aforesaid Notice inviting e-Tender including appendix 'A' to Notice inviting e-tender.
3. This estimate, however not a guarantee and is merely given as a rough guide and if the work costs more or less, tenderer will have no claim on this account.
4. The tender shall be based as mentioned in aforesaid Notice inviting e-Tender including appendix 'A' to Notice inviting e-tender.
5. The work is to be completed within the period as indicated in aforesaid Notice inviting e-Tender including appendix 'A' to Notice inviting e-tender and Schedule 'F' attached hereto.
6. The Cantonment Board, Allahabad will be the Accepting Authority here in after referred to as such for the purpose of this contract.
7. Tender forms , General conditions of contract and other necessary documents together with technical bid Part-A and Part-B ,Schedule 'A', 'B', 'C', 'D' 'F' and Notice inviting E-Tenders with its appendix 'A' have been uploaded which can be obtained from Government portal address <https://defproc.gov.in/nicgep/app> (organization Dir. Gen. Defence Estates, HQ).
8. The Chief Executive Officer will return the earnest money wherever applicable to all unsuccessful tenderers after taking necessary decision by the Cantonment Board.
9. The Chief Executive Officer either return the Earnest money to the successful tenderer on receipt of an equal amount of security deposit or will retain the same on account of part of security money if such transaction is feasible and balance amount of security deposit will be deposited by the successful tenderer within specified time.
10. The tenderer shall be deemed to have full knowledge of all relevant document, samples, site, etc, whether he has inspected them or not.
11. Tenders will be received online only in two bid systems by the Chief Executive Officer, Cantonment Board, Allahabad on or before the due date and time indicated in the aforesaid Notice inviting e-Tender.
12. Any tender which proposes any alterations to any of the conditions of this contract or proposes any other condition of any description whatsoever is liable to be rejected.
13. The submission of tender by a tenderer implies that he has read this notice and the conditions of contract and has made himself aware of the scope and specifications and drawings of the work to be done and of the conditions of sites and materials, tools and plant, labours etc required for proper completion of work in all respect and local conditions and other factor bearing on the execution of the work.
14. Tenderers must be very careful to quote a bonafide tender complete with all the documents forming part of the tender. A bonafide tenderer must satisfy each and every condition laid down in this notice.
15. The Cantonment Board, Allahabad (the Accepting Authority) does not bind itself to accept the



lowest or any tender or to give any reason for not doing so.

16. This notice of tender shall form part of the contract documents / contract agreement. The successful tenderer / contractor on receiving intimation of acceptance of his bid by accepting authority shall within the time as specified in Schedule 'F' deposit security money equal to 10% of tendered amount and execute contract agreement on the prescribed format of Cantonment Board Allahabad which is available in the Office of Chief Executive Officer for inspection. The Chief Executive Officer shall issue letter of award of contract on behalf of Cantonment Board, Allahabad. In the event of lowest / successful tenderer fail to deposit Security money and execute contract agreement, the Earnest Money deposited by him shall be forfeited.

In addition, such tenderer and his related firm shall not be allowed to participate in any tender for one year in the Cantonment Board, Allahabad.

17. The **Cantonment Board, Allahabad** will be the Accepting Authority of the tender. The Cantonment Board, Allahabad / Chief Executive Officer does not bind to accept the lowest or any tender or to give any explanation for not accepting the lowest tender and will reserve the right at any time after the acceptance of a tender to keep back from the contractor. The Board/CEO also reserves the right to accept the tender in part for any of the item or works and tenderer shall be bound to execute the same at the rates quoted by him/ them.
18. The successful tenderer will have to execute an agreement within the prescribed period and shall bear all stamp duty in this connection.
19. All corrections and alterations in the bid documents must be attested by the full signature of the person submitting the tender. No. tender containing erasures or overwriting will be considered.
20. The contract shall not be subletted or assigned without the permission of the Chief Executive Officer, Cantonment Board Allahabad, Allahabad.
21. The successful tenderer should pay the necessary security deposit stipulated by the Administration and may be required to execute a separate agreement in respect of supply of electricity and water to the pay & Use Toilets.
22. Bidders are required to sign on each page of the tender documents in absence of which the bid will be out rightly rejected.
23. Subject otherwise provided in this contract all notices to be given on behalf of the President of India and all other action to be taken on his behalf may be given or taken on his behalf by Chief Executive Officer, Cantonment Board Allahabad, Allahabad or his authorized officers.
24. If a tenderer expires after the submission of the bid/tender or after the acceptance of his tender, Cantonment Board Allahabad shall deem such tender of contract as cancelled. If a partner of the tender firm expires after the submission of their tender or after acceptance of their tender, the Railway should deem such tender or contract as cancelled unless the firm retains its original characters. Cantonment Board Allahabad shall be approached by the firm to this effect submitting fresh details of partnership deed etc.
25. (a). In case the bidding firm is partnership firm, it shall submit all documents in support or partnership and constitution of the firm including registration deed and power of attorney if any, along with the tender. Tenders not accompanied by such documents will not be considered. The tender shall be the individual (S) legally authorized to enter into commitment on behalf of all the partners of firm. (b) The tenderer in his individual capacity will submit proof of Identity & Address with the Tender document. (c) If the Contracting firm is a sole

proprietorship firm at the time of agreement, "Contractor" should be followed by such expression viz. "which expression shall, unless otherwise excluded by or repugnant to the subject or context men and include each of his heirs, executors, successors in interest agents; nominees, servants, beneficiaries etc."

26. Each page of the Tender documents is to be signed by the tenderer or power of attorney holder. In case of Tender being submitted by partnership firm, tender document must be signed separately by each partner and in absence of anyone or more of the partner by the person/persons holding power of attorney from such absent partner/ Partners authorizing him/them to do so. In any event, the names and address of all the partners must be described in writing.
27. All disputes and difference of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the contract period or after its completions and whether before or after determination of the contract shall be referred by the contractor to the Cantonment Board Allahabad for arbitration.
28. The contractor should abide by the conditions contained in conditions of the Tender and the tender documents of the contract. He shall also abide by the any instruction relating to the Pay & Use issued by Chief Executive Officer, Cantonment Board Allahabad or any official on his behalf from time to time. The contractor shall abide by all decision taken by Cantonment Board Allahabad either prior or during the currency of the contract.
29. If at any stage information furnished by the contractor is found false, contract awarded is liable to be cancelled immediately without any notice.
30. The contractor shall comply with the provision of the Minimum Wages Act 1948 and the rules made there under.
31. Chief Executive Officer, Cantonment Board Allahabad may at any time, by notice in writing summarily terminate the contract/ license without compensation to the licensee in any of the following events, that is to say- (a) if the Licensee being an individual or if a firm, any partner thereof, shall at any time, be adjudged insolvent or shall have a receiving order or order for administration of his estate made against him or shall take any proceeding for composition under Insolvency Act for the time being in force or make any conveyance or assignment of his effects or enter into any assignment or composition with his creditors or suspend payment or if the firm be dissolved under the Partnership Act, or (b) if the Licensee being a company is wound up voluntarily or by the order of a Court or a Receiver, Liquidator or manager, or (c) if the Licensee commits any breach of the license agreement not herein specifically provided for. Provided always that such determination shall not prejudice any right of action or remedy which shall have accrued or shall accrue thereafter to the Railways for any extra expenditure he is thereby put to and the Licensee shall, under no circumstances, be entitled to any gain or re- purchase.
32. Laws governing the License (i) This license shall be governed by the Laws of India for the time being in force. (ii) The place of performance or place of payment under the license, the license shall be deemed to have been made at the place from which the acceptance of license has been issued.
33. Jurisdiction of courts – The courts of the place from where the acceptance of license has been issued shall alone have jurisdiction to decide any dispute arising out of or in respect of the license.
34. **FORCE MAJURE**
  - i. In the event that any of the Parties hereto finds unable, by reason of a case of "Force Majeure" to carry out its obligations hereunder in whole or in part. The

obligation of such Party to the extent that they are affected by such " Force Majeure " shall be suspended as long as impossibility so caused shall last but not thereafter. The adverse situation created by such " Force Majeure " shall be remedied as far as possible. With reasonable dispatch. Signature of the tenderer (s).

- ii. The term "Force Majeure" as used herein shall mean any Act of God and any event, whether accidental or not, beyond the will and control of the Party affected by such event (but not necessarily unpredictable) such as war, whether declared or not, riot, insurrection, civil commotion, sabotage, strikes, lock out, or other disturbance, accident, fire, earthquake, flood explosion, damage to plant or installations, epidemic, quarantine restrictions, epidemic, quarantine restrictions, absence of the usual means of transport and embargoes, the occurrence of which event could not have reasonable by foreseen or provided for by a man of common prudence exercising due diligence together with the steps taken by it to avoid or minimize the adverse effect of such Force Majeure event, as also the cessation of such event.
- iii. The party affected by " Force Majeure " shall have notice thereof to the other party setting forth all necessary particulars concerning the giving of the said notice, obligations of the Party giving such notice shall be suspended as said above and the Parties shall consult together with the view to determining mutually acceptable measure to overcome the difficulties arising there from.

**35.**The Contractor shall indemnify, protect, defend and hold harmless Cantonment Board Allahabad, its officers, employees and agents from and against any and all demands, claims suits and causes of action and any and all liabilities, costs expenses, settlements and judgments arising out of the failure of the Contractor to discharge its obligations under this Agreements and to comply with the provision of applicable laws and any permit or approval that may have been obtained or may be required or arising out of or attributable to any act or omission of the service provider/ contractor.

**36.**Site shall be allotted for a period of 05 years which will commence from date on which each site is physically handed over to bidder. Thereafter, it shall be at discretion of administration and subject to such terms as Cantonment Board administration may decide from time to time.

**37.**Ownership of toilets will continue to be with Cantonment Board Allahabad.

**38.**No waste to be dumped into or near the river.

**39.**Firm shall bear Income tax and GST on its own.

**40.**If the rules are violated the firm will have to vacate the place immediately without notice.

**41.**Contractor will have to submit his/her three photographs of his /her representatives to Obtained identity proof from the office.

**42.**Board and Chief Executive Officer reserves the rights to enforce any new conditions for the welfare of the public w.e.f any time. The contractor will have to strictly follow the orders of Chief Executive Officer.

**43.**Any dispute arising in the tender will be resolved by the Board as per Cantonment Act 2006 and Board's decision will be final and binding.

**44.**No minor can participate in the bidding.

45. If found that the contractor is not running the contract properly or not following the terms and conditions, contract can be terminated or can be penalized by the Chief Executive Officer, the penalty amount will be deducted from deposited earnest money.
46. Fee will be Rs. 5/- per head to use toilet facility and Rs. 10/- per head for use of bathrooms . Urinal facility will be free of cost. Contractor outside and inside the toilet blocks will have to provide clean & hygiene environment.
47. Contractor shall operate and maintain building of complexes to entire satisfaction of the Cantonment Board. Contractor shall regularly clean toilets, urinals, floor, walls and ceiling etc as well as interior & exterior of building. He shall ensure the requisite quantity of cleaning material such as phenyl, acid, and naphthalene balls for clean and foul free environment at all times in toilet complex and its vicinity.
48. The Bidders who's Bids are responsive, complete and in accordance with the Tender document shall be evaluated. Out of these, the bidder whose bid is the highest will be finally selected and adjudged as the successful Bidder for the opted space of that toilet/urinal/bathroom complex.
49. In case two or more responsive Bidders have quoted the same license rent for space which is also the highest license rent offered, then all such bidders will be given an opportunity to revise their financial bid by submitting fresh Financial bid(s) in a sealed cover, which shall necessarily be higher than the previous bid. The revised financial bid shall be submitted by the date and time as notified to the concerned Bidders.

Various critical dates are available on Government e-procurement portal <https://defproc.gov.in/nicgep/app>.
3. Successful tenderers shall have to deposit security money and execute agreement on the prescribed format available in Cantt. Board office. The earnest money deposited by the contractor pledged to the Chief Executive Officer, Cantonment Board Allahabad shall be forfeited if he (successful tenderer) fails to deposit security money and execute contract deed/contract agreement within stipulated time notified in Schedule 'F' and work shall be cancelled and such contractor and his related firm shall not be allowed to participate in any tender for 10 months in Cantonment Board Allahabad.
4. The **Cantonment Board, Allahabad** will be the Accepting Authority of the tender. The Cantonment Board, Allahabad / Chief Executive Officer does not bind to accept the lowest or any tender or to give any explanation for not accepting the lowest tender and will reserve the right at any time after the acceptance of a tender to keep back from the contractor.
